

Privacy policy

In compliance with the provisions of Organic Law 15/1999, of 13 December, on the Protection of Personal Data, users of this website are informed that {razon_social} complies with all the obligations, duties and guarantees to which it is obliged by virtue of the provisions of current legislation on the protection of personal data and complementary regulations.

The data provided by the USER to {razon_social}, on completing the web form, will be incorporated into a database for which {razon_social}, an entity with registered address at {direccion_fiscal}, with tax identification number {cif}, is the owner and responsible.

By providing personal data to {razon_social}, the USER consents to and authorises the automated processing of his/her personal data by {razon_social}, which will be used by

{razon_social} which guarantees by means of this PRIVACY POLICY the absolute confidentiality of all personal data provided by the USER. In this respect, the USER undertakes, for his part, to maintain the same confidentiality regarding all the data provided, and particularly with regard to his private access codes.

The main purpose of the automated processing of the data provided by the Users {razon_social} will be to enable or facilitate the management of a more personalised service for the USER and to guarantee the correct provision of the service contracted by the USER. Likewise, your data may be used for statistical and advertising purposes, offering you new products and promotions offered by {razon_social} or by third parties.

Users' rights: In accordance with the provisions of Title Three of Organic Law 15/1999, of 13 December, on the Protection of Personal Data, USERS are informed of the possibility of exercising, in the event that they deem it appropriate, and without the need for a justified cause, the rights of access, rectification, cancellation and opposition of their personal data by contacting {razon_social},sita

at {fiscal_address} with tax identification number {cif}.

- Right of access: The interested party shall have the right to request and obtain, free of charge, information on their personal data subject to processing, the origin of such data, and the communications made or planned to be made of the same. The information may be obtained by

simply consulting the data by means of their visualisation, or by indicating the data being processed by means of writing, copy, fax or photocopy, certified or not, in legible and intelligible form, without the use of codes or codes requiring the use of specific mechanical devices.

This right may only be exercised at intervals of no less than twelve months, unless the data subject accredits a legitimate interest to that effect, in which case it may be exercised earlier.

- Right of rectification and cancellation: Personal data whose processing does not comply with the provisions of Organic Law 15/1999 and, in particular, when such data is inaccurate or incomplete, may be rectified or cancelled, as the case may be.

The {razon_social} shall enforce the right of rectification or cancellation of the interested party within ten days.

The cancellation will lead to the blocking of the data, being kept only at the disposal of the Public Administrations, Judges and Courts, for the attention of possible liabilities arising from the processing, during the period of prescription of these.

Once the aforementioned period has expired, the data will be deleted. In the event that the rectified or cancelled data had been previously communicated, {razon_social} will notify the rectification or cancellation carried out to the person to whom it was communicated, in the event that the processing is maintained by the latter, who must also proceed with the cancellation.

For the procedures in which the rights of opposition, access, rectification or cancellation are exercised, the provisions of the regulations shall apply, without any consideration being required.

Obligatory nature of the information provided by the User: The data provided by the User in the registration procedure must always be true and accurate, being obliged to communicate any changes made to them. The data to be completed in this procedure are those that have been considered pertinent, adequate and not excessive in relation to the purpose for which they were obtained. In the event of refusal by the User of any of the data requested, {razon_social} reserves the right to exclude the User from accessing and using the contents and services of this website.

Transfer of data: consent is considered to be expressly granted for the transfer of the data collected in the order form on the {url_web} website when this transfer is made to the suppliers necessary to comply with the purpose of said file.

Security and cookies: {razon_social} guarantees users that its website complies with the levels of security established in the regulations relating to data protection, and that it makes use of all the technical means at its disposal to prevent any alteration, loss, unauthorised access or misuse of this data.
